### OLMSTEAD COMMISSION

#### Membership

- Individuals appointed by the Governor according to enabling Executive Order

#### Roles & Responsibilities

- Monitor North Dakota's efforts to comply with Olmstead vs. L.C.
- Host public hearings once per biennium (in non-session years) to gather comment from advocates, consumers of services, providers, and the public
- Meet twice per year as a Commission
  - Receive Reports from Olmstead Work Group Subcommittees
  - Authorize changes to the N.D. Olmstead Plan
  - Develop recommendations for ongoing work and reports
- Submit recommendations and a report to the Governor

### OLMSTEAD WORK GROUP

#### Membership

- Determined by Commission Members to include representation from advocates, consumers/clients, providers, and other agency personnel

#### Roles & Responsibilities

- Actively monitor progress on the implementation of the N.D. Olmstead Plan
- Recommend goals and tasks
- Help identify priorities, issues, concerns, and potential solutions
- Designate subcommittees to complete identified Plan tasks
- Report to Governor's commission on plan's implementation
