SNAP 2020 Cost of Living Adjustments (COLAS) are effective 10-01-2019. For TECS, SNAP cases will be unauthorized for the benefit month of October 2019 to reflect these mass changes. Adequate notice must be provided. For SPACES, we will be sending a FYI for processing as there will be a mass update. The benefit month of October 2019 will be displaying beginning August 22, 2019 and the updated changes will be in SPACES.

The mass changes include the following:

- Changes to the minimum benefit amount.
 - From \$15 to <u>\$16</u>
- Changes to the standard deduction. For a household size of:
 - 1-3 from \$164 to \$167
 - 4 from \$174 to <u>\$178</u>
 - 5 from \$204 to <u>\$209</u>

• 6+ from \$234 to <u>\$240</u>
