Welcome and Recap from the November Meeting

Davonne Eldredge welcomed the committee members and reviewed the work completed in the November meeting.

February Agenda Review

Davonne Eldredge reviewed the agenda for the day and outlined the work to be completed. Resources added to the TEAM file were previewed.

Public Comment Feedback Review

The committee broke into grade-span groups to review and discuss the feedback received on the second draft of the standards. As they examined the feedback, revisions were made to the draft. Responses to feedback were noted in the TEAM file.

Discussion of Rollout of the New Standards

Jason Mattheis led a discussion regarding the rollout opportunities of the new standards. The committee provided input regarding the venues that could be used for the rollout. Mr. Mattheis also discussed the potential professional development needed to implement the new standards. He recorded the feedback provided. This feedback will assist EduTech in planning for the standards rollout and future professional development opportunities.

Revisions to the Standards

The committee broke into small groups to discuss potential revisions to the standards. Revisions were noted in the TEAM file.

Vertical Alignment of the Standards

The committee reviewed the skill progressions and discussed vertical alignment. As they discussed alignment and skill progressions, revisions to the standards were made in the TEAM file.

Review of the Crosswalk Between 2019 and New Standards

The grade-span groups reviewed the crosswalk between 2019 and new standards. They added revisions to the standards and checked the alignment. As they worked, they noted reasons for changes made in the TEAM file.

Review of the Disciplinary Literacy Resource Document

The committee reviewed the revised Disciplinary Literacy document in the last session to ensure that the revisions to the standards made during the February meeting were reflected.

Final Review of the Standards

The committee reviewed the standards, crosswalk, and disciplinary literacy documents. They discussed revising the document's format and noted suggestions in the TEAM.

Vote to Move the Document Forward for Approval

After the group had completed the final review, the committee members were asked if they had approved sending the final draft forward for Superintendent Baesler's approval. The committee voted unanimously to move the document forward for approval.

Mrs. Eldredge explained the process of finalizing the standards for approval and the approval process. The committee members were thanked for their work, and the meeting adjourned at 3:30 PM.
