

Emergency Assistance for Nonpublic Schools (EANS) Program

Estimated Service and Assistance Allocations

The following estimated allocations reflect the total amount for reimbursement, services, and support that will be made available to eligible nonpublic schools through the EANS program, based on the data that was supplied by nonpublic schools for the 2019-2020 school year. *This is only an estimate, based on current data*. It is likely allocations will change after nonpublic schools have identified their intent to participate in the EANS program based on the submission of applications.

Allocation Formula: To advance equity and fulfill the essence of the federal law, the NDDPI used a perpupil formula with two components:

- 1) Base Grant The formula assigns each school a per pupil regardless of a student's socioeconomic status based on 2019-2020 K-12 enrollment.
- 2) Supplemental Grant In addition to the base grant, a school will receive an additional supplemental amount for each 2019-2020 K-12 student identified as low-income.

These planning allocations are based on 2019-2020 state enrollment data for nonpublic schools.

Each eligible school will submit 2019-2020 K-12 enrollment and low-income student data as a component of the required application to participate in this program. These figures will be used to calculate final allocations.

Intent to Participate: Each eligible school must submit the required application to participate in this program. Failure to so by April 30, 2021, indicates the nonpublic school's decline to participate.

Minimum Allocation: Eligible schools that served K-12 students during 2019-2020 but fell below \$10,000 were automatically allocated a minimum of \$10,000.

Request Structure: The NDDPI is finalizing the administrative structure that will allow nonpublic schools to request reimbursements, services, and supports and will share those details as soon as they are available.
