Summer Programs – S-EBT

- NEW Permanent Program similar to Pandemic EBT
- School Aged children attending a school that participates in NSLP
 - Pre-K included if they are served meals through NSLP
- Most eligible students no application needed
 - Direct Certification through SNAP, TANF, FDPIR
 - Homeless, Migrant, Foster
 - Eligible for Free/Reduced-price meals in SY 23-24 (Not State 200) and attending an NSLP school



S-EBT

- Some Households will need to apply
 - Students from CEP Schools not Directly Certified.
 - Students who may be eligible but haven't applied for Free/Reduced Benefits and attend an NSLP School
- NDDPI Staff may reach out to school personnel regarding the status of students, or guardian information.

S-EBT Benefits

- \$120 EBT Benefit Card per Eligible Student
- Cards will be mailed around May 16th (should be received by June 1)
- Additional card issuances will be completed throughout the summer as additional students become eligible through applications
- Benefits can be used just like SNAP benefits
- Benefits expire 122 days after issuance



Direct Certification through Medicaid

- New in SY 24-25
- Identify students who are eligible for free or reduced-price meals based on household income through Medicaid
- Same eligibility percentages 130% or less = Free, 131-185% = Reduced-Price
- Notifications in STARS: DHS-MF = Medicaid Free

DHS-MR = Medicaid Reduced

New CEP Guidelines

- Final Rule in September 2023
- Changes ISP minimum threshold from 40% to 25%
 - Students who participate in SNAP, TANF, FDPIR, Homeless, Runaway, Migrant and Foster
- 1.6% Multiplier remains the same
- Federal/Local Cost Sharing

Continuation of ND Extended Eligibility Guidelines


- Year 1 (2023-24)
 - Approximately 1800 students were eligible in 2023-24
- New Name: "State 200"
- Highlight success stories in your district for Legislators
- SY 24-25 will be on the DPI website by June 2024
- Cannot accept applications until July 1, 2024 Remember: Applications MUST be determined within 10 days of receiving them!

End of the Year Reminders

- Inventory
 - ICN: "CNOD Inventory Management"
- Records Management
 Active Yr 1 Yr 2
 - Most: 3 years plus active year, i.e. 23-24; 22-23; 21-22; 20-21

Yr 3

- End of the year Financial transactions
 - Second servings/ Adult meals paid by non-Federal funds
 - Repayment of Food Service Payroll to the General Fund
 - One year only
 - Excess Funds Calculation Before reporting to DPI-Fiscal
 - Last year to include 25% extra in the calculation




Charging for Seconds/Extra Meals

- Seconds/Extra Meals
 - Two ways to consider the extra food
 - 1. Menu Planner decision must account for all food in dietary specifications

OR

- 2. Student decision must be paid for
- Nonprogram Revenue Tool
 - Revenue from Ala Carte must be higher than Food Cost
 - Office Hours: Tuesdays April 23 thru May

Procurement Requirements

- Annual Training BTSW; Across the Desk
- Procurement Policy including a Plan
- Code of Ethics for Food Service Staff
- Procurement Types
 - Micro Purchase one vendor over the entire school year
 - purchase under \$10,000
 - Small Purchase ND State \$50,000/ Check your School District
 - Must document two or more bids
 - Decision is based only on price
 - Formal Purchase Purchases from one vendor is more than \$50,000

Common Findings on Reviews

- Free/Reduced Applications
 - 10% Error in Application determination = Second Review of ALL Applications
 - Confirmation Review not done or official did not sign the verified application that was chosen from Error Prone
- Meal Counting & Claim
 - POS not at the end of the service line
 - Cashier is not trained to identify a reimbursable meal
- Meal Pattern
 - Not enough legumes or dark green vegetables during each week
 - Not using CN labeled/Product Formulation Statement to calculate amount of meat served
 - Juice is served as more than 50% of the fruit required at breakfast/lunch



Common Findings on Reviews

- Civil Rights
 - All Staff trained; not just those that went to Back to School workshop
- On Site Monitoring not completed by Feb 1st at multi-site schools
- Local Wellness Policy
 - A Triennial Assessment has not been done in the last three years.
- Smart Snacks
 - Vending machine has a non-Smart Snack-compliant food / beverage as the logo
 - Caffinated or non-Smart Snack beverages available to all students in a school that has K-8 grades
- Professional Development
 - Waiver not on file for new cook not meeting hiring standards
 - All nutrition staff must complete training each year
- Buy American Exception paperwork not completed
- Resource Management Nonprogram Revenue Tool not completed
