Summer EBT

- \$120 EBT Benefit Card per Eligible Student
- Cards to be mailed by May 16th (expected delivery by June 1)
- Additional card issuances will be completed throughout the summer as additional students become eligible through applications
- Benefits can be used just like SNAP benefits
- Benefits expire 122 days from issuance



Summer EBT

40,000 Students are ALREADY eligible through the Streamlined Process

- Direct Certification through SNAP, TANF, FDPIR, Medicaid
- Homeless, Migrant, Foster
- Eligible for Federal Free/Reduced-price meals in SY 24-25 and attending an NSLP school
- State 200 (Exempt State Benefit) is NOT eligible.

Direct Certification through Medicaid

- New in SY 24-25
- Directly certify students who are eligible for free or reduced-price meals based on household income through Medicaid
- Same eligibility percentages 130% or less = Free, 131-185% = Reduced-Price
- Notifications in STARS: DHS-MF = Medicaid Free

DHS-MR = Medicaid Reduced

ALL schools need to check DC list at least once per month!

- Cannot qualify for Medicaid from an Application
- Extended Eligibility is allowable
- A Free Application Supersedes a RDC (Common Review Finding)
- We will continue to make improvements



ND Extended Eligibility Guidelines State 200? Now State 225?

Year 1 (2023-24) Year 2 (2024-25)

Approximately 1800 students were eligible in 2024-25

SY 25-26 will be on the DPI website by June 2025

Income Guidelines

Application template with Household letter

Consider Online applications

Cannot accept applications until July 1, 2025

Remember: Applications MUST be determined within 10 days of receiving them!

Reminder – the State has Primero Edge, online application available for use.



Community Eligibility Provision (CEP)

Schools or districts qualify if 25% are "Identified Students"

- •Households receiving SNAP, TANF, Medicaid, Foster, Homeless or Migrant
- No Applications are needed
- Schools must re-certify every four years
- Reimbursement is based on a formula
 - •ISP x 1. 6 = Percentage of meals reimbursed at the federal free rate.
 - •Remaining meals are reimbursed at the federal paid rate



FFVP Application

- Applications available first part of May
 - Reapplying Schools in good standing shortened application
 - No Funding Changes
 - More Training Next Year



ND House Bill 1132

"Whole, pasteurized milk served in bulk milk dispensers."

Schools may establish a policy allowing a school to serve whole, two percent and flavored pasteurized milk through a bulk milk dispenser.

All NSLP Rules still apply:

- Must offer at least two choices.
- Must be fat free, 1% flavored or unflavored.
- By July 1, 2025, flavored milk must meet added sugar limits:
 - No more than 10 grams of added sugar per 8 ounces.

Guidance will be on our website.



Buy American Provision

- 1. Ensure Buy American is communicated to Vendors
- 2. Document <u>"Exceptions"</u>
 - a. NEW: Document Exceptions NOT on FAR List
 - b. Must have documentation on the reason: price or availability
- 3. NEW for SY26: No more than 10% Foods

can be Non-Domestic

- a. All commercial food purchase for school meal programs
- b. Separate out ALL nondomestic purchase
 - Do not include USDA Foods

Starting SY 26

– no more than 10% of commercial food purchase can be Foreign Product.

End of the Year Reminders

- **1. School Food Service Account**
 - Check the Ending balance of the Foodservice account
 - cannot be Negative.
 - cannot have a larger balance than <mark>6</mark>months of operating. (Excess Funds)
 - 2. Paid Lunch Equity (PLE)
 - Same exemption as this year: \$0 or positive balance in FS account
 - Request exemption during Renewal process



Setting Meal & Ala Carte Pricing

1. Student Breakfast and Lunch pricing

\$.10 increase each year

2. Adult Meal Pricing

Depends on Reimbursement rates...

a. Pricing schools: Must be at or above

2025 Average Meal Prices - Statewide

POS to make sure that Reduced-price breakfast and lunch are set to \$0! These meals should be free for students because of reimbursement from the STATE of ND



The Letters of Notification to Households about their Eligibility. -These should not be One-Liners. Access the DPI templates.



Your Procedure for addressing Unpaid Meal Charges = Bad Debt. - Schools cannot simply zero out negative balances when they are no longer collectible.

- A non-Federal source (usually the General Fund) must be used to pay off those negative balances.
