Re: Preliminary Review of Accountability Data Prior to Public Release

Annually, state education departments are required to create an accountability report for every public school in the state. Accountability results serve as a tool for school and system leaders to celebrate successes, identify areas of underperformance, and proactively implement school improvement strategies. Today, the North Dakota Department of Public Instruction (NDDPI), in collaboration with North Dakota Information Technology (NDIT), the North Dakota University Systems (NDUS), and other partners, is releasing preliminary accountability reports through an internal test site (<https://uatinsights.edportal.nd.gov>) to provide schools an opportunity to review performance results privately between today and **Monday, November 10, 2025**, in advance of the public release. **NOTE:** To view information on the test site, you must be connected to the state's internet, which is STAGEnet. Additional changes, such as visuals and explanation tabs, will continue to be updated during this review period.

Actions Needed

School and district administrators must carefully review the data used to create the School Accountability Reports. There is only a short window of time to ask questions, get clarification, or appeal data before the reports are made available to the public, and it is imperative that schools follow these steps:

1. [Review ND School Accountability Calculation Guide](#): The Calculation Guide provides an in-depth overview of the technical aspects of the School Accountability Report and how points are calculated.
2. [Review Data in the K-12 Reporting and Analytics Portal](#): School personnel are strongly encouraged to review their secured accountability data within the K-12 Reporting and Analytics Portal, which provides a series of unsuppressed accountability dashboards, including Accountability Index scores, the allocation points earned versus points available, and access to a plethora of data.
 - a. Once logged in, click on "Reporting" in the lower left-hand side navigation, then click "Accountability Report Card," followed by "Accountability Index" under "Fundamentals." All sections contain filters to select performance data presented in aggregate form or disaggregated by subgroups. Additionally, sections for "Report," "Trend," "Data," and "About" are displayed for all measures, with "Roster" options available for applicable measures. Rosters are provided to help school districts better understand performance results.

- b. Conduct data checks using the resources provided on the [Accountability website](#), such as the Validation User Guide and corresponding worksheet.

Appeals of Possible Data Discrepancy

If you wish to submit a formal written appeal of a data discrepancy, there is a specific process to follow. The NDDPI, with support from NDUS and other partners, has created a ticketing process to answer all questions and appeals. Click [here](#) to access the steps to follow to submit a ticket. The NDDPI requests that all appeals of data discrepancy be submitted by 5:00 p.m. CDT on **Monday, November 10, 2025**.

School Improvement

Schools will be selected as "[Targeted Support and Improvement \(TSI\)](#)" or "[Comprehensive Support and Improvement \(CSI\)](#)" based on accountability results. The superintendent, building principal, and school board president will be notified via a formal memo in the next few days if a school is identified or has exited. The websites above will be updated for the public after the schools are notified.

Final Accountability Reports

The NDDPI will not consider any School Accountability Report final until all appeals of data accuracy are resolved. The NDDPI anticipates releasing final accountability reports on Insights for public view in mid-November.

Notification Requirements

Parent Notification: Under ESSA, all public school districts receiving federal funding must notify the parents of each enrolled child in the school regarding the performance measures outlined in the state's accountability system. A [sample parent letter](#) is available on the website. Schools should wait to disseminate information to parents until **after the official release is posted, as changes could still occur**.

Dashboard Notification: Federal law also requires each district to provide a link to the Dashboard on the website of the district. If the district does not operate a website, providing the information to the public in another manner determined by the district is acceptable. A [sample website notification](#) is available.

Questions

Anyone with questions about their School Accountability Report should send an email request for assistance to NDDPI (dpiaccountability@nd.gov) with the subject line, "Review of School/District Data." Confirm your status as the designated district representative, specify your question or data appeal, and provide your phone number and email address. Questions will be forwarded to the appropriate individual to respond. The NDDPI has an established ticketing process and will answer all requests for assistance and appeals in the order received.
