## Workforce Ready

  - 4 credits of Career and Technical Education (CTE), with 2 of those credits in the same CTE Coordinated Plan of Study
  - 3 credits of the same world, indigenous, or sign language
- The student has received a composite ACT score of 24; or scores of 5 or higher on all three WorkKeys exams (Applied Math, Graphic Literacy, Workplace Documents) - *include score report*

Two or more of these six indicators:
