15.1-11-02. County Superintendent of Schools - Assignment of duties - Waiver

Notwithstanding any other provision of law, a board of county commissioners, by majority vote, may choose not to employ a county superintendent of schools, provided the board of county commissioners assigns all such statutory duties, obtain approval by many of the school board presidents whose districts have their administrative headquarters in the county, and obtains written approval of the assignments from the Superintendent of Public Instruction.
