**DISPUTE RESOLUTION SUMMARY
JULY 1, 2023– JUNE 30, 2024**

Eight requests for **IEP Facilitation** were received:

- Four requests resulted in the successful completion of the IEP.
- One request the district chose not to participate in facilitation.
- One request the district met with the parent and resolved the issues without facilitation.
- One request the team met but did not result in the completion of the IEP.
- One facilitation did not occur because the IEP meeting was not held this year.

Four requests for **Mediation** were received:

- Two requests did not result in the parties signing a Mediation Agreement.
- One request resulted in the parties signing a Mediation Agreement.
- One request resulted in the parents choosing not to participate in mediation but instead chose to file a *Request for a State Complaint Investigation*.

Nineteen requests for **Complaint Investigation** were received:

- Thirteen requests met the criteria, and an investigation was completed.
 - ******One request was filed and counted in the 2022-2023 school year, but the outcome was completed and reported in the 2023-2024 school year or federal reporting period.
- Three complaint requests resulted in the parents withdrawing the *Request for Complaint Investigation*.
- One request resulted in the parents submitting a *Request for a Systemic Complaint Investigation* but was dismissed due to it not meeting the requirements for filing a systemic complaint.
- One complaint request did not meet the requirements for filing a complaint and the parent was offered the option to resubmit.
- *****One request met the criteria and is currently being investigated (the outcome of the allegations will be reported in the 2024-2025 Annual Report).

One Request for an **Expedited Due Process Complaint Notice** was received:

- One request resulted in the parties reaching a resolution agreement. The agreement resolved the disputed issues and issued a Notice of Dismissal.
