**NARRATIVE:** Driver 1 was traveling northbound on 16<sup>th</sup> Street NE approximately 200 yards north of 12<sup>th</sup> Avenue NE. Driver 1 lost control of his 2000 Pontiac Bonneville and collided with a trailer being towed by a 2004 Freightliner traveling southbound driven Botha. The initial collision with Botha caused Driver 1 to veer to the right. Driver 1's vehicle lost its driver's side front tire causing Driver 1 to reenter the southbound lane of traffic resulting in a head-on collision with a 2019 GMC Yukon being driven by Fee who was traveling southbound.

Driver 1 was transported by his mother to Altru Hospital in Grand Forks for injuries sustained in the crash. Fee and her juvenile children received medical treatment on-scene but were not transported to a medical facility. Botha and his passenger were uninjured in the crash.

Vehicle 1 and Vehicle 3 sustained disabling damage and were towed from the crash scene. Vehicle 2 was able to be driven from the crash scene after repairs were made to change a damaged tire.

The crash remains under investigation by the North Dakota Highway Patrol.
