## **Two Vehicle Injury Crash – Horace – June 13th**

What: Two-vehicle head-on crash in Horace

Where: Cass County Road 17 & 6th Ave N - Horace

When: June 13<sup>th</sup>, 2024 @ approximately 10:55 pm

Road, Weather & Light Conditions: Dry roads, clear, nighttime – lighted

**Type of Crash:** Two vehicle head-on injury crash

Agencies Involved: NDHP, Cass County SO, Horace FD, Sanford Ambulance, Sanford Life

Flight

**Vehicle No. 1:** 2011 Buick Lacrosse

**Driver No. 1:** McKenzie Moser, 18 YOA female, Horace, ND - injured

**Restraints:** Unrestrained – air bag deployment

Charges: DUI and DUI Refusal

**Vehicle No. 2:** 2010 Honda Civic

**Driver No. 2:** 16 YOA female driver - injured Restraints: Restrained – all airbags deployed

Charges: None

Passenger No. 1: 16 YOA female, restrained – injured – front passenger seat
Passenger No. 2: 14 YOA female, restrained – injured – rear seat passenger

## NARRATIVE:

On June 13<sup>th</sup>, 2024, at approximately 10:55 pm a two-vehicle head-on injury crash occurred at the intersection of Cass Co. Rd. 17 and 6<sup>th</sup> Ave N in Horace, ND.

Moser was traveling southbound on Co. Rd. 17 in the Buick and crossed into the northbound lane and into the path of the Honda driven by a 16 YOA female. The vehicles struck head-on in the northbound lane of Co. Rd. 17 at the intersection with 6<sup>th</sup> Ave N.



After colliding, the Buick came to rest in the northbound lane facing south and remained upright. The Honda came to rest facing north, partially in the ditch in the southeast corner of the intersection. The Honda remained upright as well.

Moser's vehicle was involved in a hit and run property crash in the city limits of Fargo prior to this crash. Further details of this crash can be found with Fargo PD.

The three juvenile occupants in the Honda were all transported to Sanford Hospital in Fargo. The 16 YOA driver and 14 YOA passenger were transported by Sanford Ambulance. The 16 YOA passenger was transported by Sanford Life Flight. All three suffered serious injuries.

Moser was arrested on scene and transported to Sanford Hospital in Fargo. She was charged with DUI and DUI-Refusal. She remains hospitalized for her injuries.

The names of the juveniles will not be released.

The crash remains under investigation by the North Dakota Highway Patrol and Cass County Sheriff's Office.
