## **Two-Vehicle Injury Crash - Fargo**

What: Serious Injury Crash

Where: Intersection of 52nd Avenue South and 31st Street South, Fargo, ND

When: April 12, 2025, at approximately 7:31 PM (Central Time)

**Driver No. 2:** Marcella Schnabel, Detroit Lakes, MN, 79, minor injuries

**Restraints:** Seatbelt in use, airbag deployed

Passenger No. 1: Ardelle Schwartzrock, Hawley, MN, 82, minor injuries

Restraints: Seatbelt in use, airbag deployed

Passenger No. 2: Andreya Halvorsen, Hawley, MN, 18, no injuries

**Restraints:** Seatbelt in use

**NARRATIVE:** On April 12, 2025, at approximately 7:31 p.m., a two-vehicle serious injury crash occurred at the intersection of 52nd Avenue South and 31st Street South in Fargo. A Triumph Street Triple motorcycle, driven by Avery Quiner, was traveling eastbound on 52nd Avenue approaching the intersection. A Chevrolet Malibu, driven by Marcella Schnabel, was westbound on 52nd Avenue in the left turn lane to go south on 31st Street. The Chevrolet entered the intersection and began turning. The motorcycle entered the intersection and attempted to steer right before contact occurred. Quiner was ejected from the motorcycle and sustained serious injuries and was transported to a local hospital by ambulance. Schnabel and



one passenger, Ardelle Schwartzrock, reported minor injuries; a second passenger, Andreya Halvorsen, reported no injuries. Both vehicles were disabled and towed from the scene.

Earlier in the evening law enforcement recorded this motorcycle driving at speeds up to 140 mph but declined to pursue due to safety reasons.
