LOGAN COUNTY FATAL CRASH UPDATE

What: Fatal Crash

Where: Highway 30, MM 22, approximately 3 miles south of Streeter

When: Wednesday, December 24, 2025; 8:34 AM

Road Conditions: Dry

Weather Conditions: Dry

Crash Involvement: Vehicle vs vehicle

Type of Crash: Head-on crash

Agencies Involved: North Dakota Highway Patrol; Stutsman County Sheriff's Office; Logan County Sheriff's Office; ND DOT; Medina Rescue; Streeter Fire; Gackle Ambulance; Gackle Fire; Sanford Aired

Vehicle No. 1: 2026 International Truck pulling a semi-trailer

Driver No. 1: Abdullahi Mohamud, 39, Moorhead, MN, fatal injuries

Restraints: Unknown

Passenger No. 1: Mursal Diriye, 41, East Grand Forks, MN, serious injuries

Restraints: Unknown

Vehicle No. 2: 2025 Kenworth Truck pulling double semi-trailers

Driver No. 2: Scott Schilling, 53, Wishek, fatal injuries

Restraints: Unknown

NARRATIVE: On Wednesday, December 24 at 8:34 a.m., Abdullahi Mohamud was driving a 2026 International truck pulling a semi-trailer northbound on Highway 30. Scott Schilling was driving a 2025 Kenworth truck pulling a double trailer southbound on Highway 30. The two vehicles collided head-on. Mohamud and Schilling died at the scene. A passenger in the International, Mursal Diriye, was injured and airlifted to Sanford Hospital-Bismarck. The road was closed with a detour in place for approximately 6 hours.

The crash remains under investigation by the North Dakota Highway Patrol.
