## **RAMSEY COUNTY INJURY CRASH**

**What:** Injury Crash

**Where:** US Highway 2, near mile marker 284; approximately 2.5 miles SE of Crary

**When:** October 22, 2025; at approximately 9:35 p.m. CT

**Road Conditions:** Good

**Weather Conditions:** Clear, dark

**Crash Involvement:** Vehicle/Vehicle

**Type of Crash:** Rear-end, Rollover

**Agencies Involved:** North Dakota Highway Patrol, Ramsey County Sheriff's Office, Nelson County Sheriff's Office, Devils Lake Fire Department, Devils Lake Rural Fire Department, and Lake Region Ambulance Service

**NARRATIVE:** On Wednesday, October 22 at approximately 9:35 p.m., an Infiniti and Chevrolet Express Van were both westbound on US Highway 2 near mile marker 284. The Infiniti struck the rear of the Chevrolet, entered the median, rolled, and came to rest in the median facing south. The Chevrolet entered eastbound US Highway 2 and driven to a stop. The driver and ten passengers were not injured. The driver of the Infiniti was transported to CHI St. Alexius Health Devils Lake and then transported to Altru Hospital, Grand Forks.

The crash remains under investigation by the North Dakota Highway Patrol.
