

NOTICE OF 2018 ANNUAL COUNTY BUDGET TO THE TAXPAYERS OF CAVALIER COUNTY

On September 5, 2017, beginning at the hour of 2:00 p.m., at the office of the Cavalier County Commissioners in the Cavalier County Memorial Courthouse in the City of Langdon, North Dakota, a hearing will be held for taxpayers of Cavalier County on the following proposed budget appropriations as adopted by the Board of County Commissioners of said county, for the maintenance, extension or improvement of all institutions, offices and undertakings supported wholly or in part by the County of Cavalier, North Dakota, for the fiscal year beginning January 1, 2018 and ending December 31, 2018.

At that time and place designated above, the Board of Commissioners of said county will meet for the purpose of hearing any taxpayer who may appear and desire to be heard in favor or against any of the proposed expenditures for which taxes are to be levied as set forth in the following statement of proposed appropriations. This includes the expenditures and appropriations for revenue sharing funds.
