

Navigating Guardianship Options in North Dakota

Court Involvement	Required: petition, hearing, evaluations, legal costs	Required: petition, hearing, evaluations. legal costs	Not required - executed privately with witness/notary	Not required – handled by Social Security Administration	Not required – agreement is informal or documented
Evaluation Required	Yes – medical and legal evaluations	Yes – medical and legal evaluations	No - individual must have capacity at time of signing	No – SSA may request basic documentation	No – based on trust and communication

Training Required	Yes – guardian training required	Yes – guardian training required	No formal training required	No formal training required	No formal training required
Less Restrictive?	No – most restrictive option	Yes – tailored to individual needs	Yes - Individual retains control and can revoke anytime	Yes – financial-only support	Yes – most empowering and least restrictive
Best For	Individuals unable to make any personal decisions	Individuals who need help in only certain areas	Individuals who want to plan ahead and choose their own decision-maker	Individuals who can manage life but not finances	Individuals who can make decisions with support

Notes on Power of Attorney (POA)

Types of POA:

- **General POA:** Broad authority over financial/legal matters
- **Durable POA:** Remains in effect if the person becomes incapacitated

Notes on Supported Decision-Making (SDM)

- A process where individuals with disabilities use trusted supporters to help them understand, consider, & communicate decisions.
- Supporters may include family, friends, professionals, or mentors.
- Agreements can be informal or documented in a Supported Decision-Making Agreement.
- Promotes independence and is recognized as a valid alternative to guardianship in North Dakota.
