### **ELIGIBILITY: Ustahiki**

- **Individuals age 18 or older providing 24-hour care to an adult who is 60 years of age and older and who needs assistance with two or more everyday activities or who is not safe to be left alone:** Watu wenye umri wa miaka 18 au zaidi hutoa huduma ya saa 24 kwa mtu mzima ambaye ana umri wa miaka 60 na zaidi na ambaye anahitaji msaada na shughuli mbili au zaidi za kila siku au ambaye sio salama kuachwa peke yake.
- **Grandparents and other relative caregivers (other than the parent) age 55 years and older caring for a child age 18 or younger:** Wazazi na walezi wengine wa jamaa (isipokuwa mzazi) wenye umri wa miaka 55 na zaidi wanaomtunza mtoto wa umri wa miaka 18 au mdogo

- **Parents or other relative caregivers age 55 and older caring for an adult with a disability between the ages of 19 to 59:** Wazazi au walezi wengine wa jamaa wenye umri wa miaka 55 na zaidi wanaomtunza mtu mzima mwenye ulemavu kati ya umri wa miaka 19 hadi 59
- **Individuals age 18 or older caring for a person with Alzheimer's disease or related dementia, regardless of age:** Watu wenye umri wa miaka 18 au zaidi wanaomtunza mtu aliye na ugonjwa wa Alzheimer's au ugonjwa wa shida ya akili, bila kujali umri.

- **Funding to cover petitioning costs for guardianships of eligible adults:**

- Adults (18 and older) who: Watu wazima (18 na zaidi) ambao:
  - **Meet the definition of incapacitated (NDCC § 30.1-26-01):** Wanakidhi ufanuzi wa kutokuwa na uwezo (NDCC § 30.1-26-01);
  - **With income at or below 100% of federal poverty level or are Medicaid eligible; and:** Kwa kipato kilichofikia au chini ya asilimia 100 ya kiwango cha umaskini wa shirikisho au wanaostahili Medicaid; na
  - **Are not eligible for Developmental Disabilities Case Management:** Hawastahili kwa Usimamizi wa Kesi za Ulemavu wa Maendeleo.

- **Assists in providing resources and referrals to residents residing in long-term care facilities who wish to transition back into community living:** Inasaidia kutoa rasilimali na rufaa kwa wakazi wanaoishi katika vituo vya huduma za muda mrefu wanaotaka kurudi katika maisha ya kijamii.

- **Receive and investigate complaints made by or on behalf of residents:** Kupokea na kuchunguza malalamiko yanayofanywa na au kwa niaba ya wakazi.
- **Complaint resolution:** Utatuzi wa malalamiko
- **Ongoing presence of local long-term care ombudsmen and volunteer ombudsmen in assigned facilities:** Uwepo endelevu wa waombudsmani wa huduma za kulea kwa muda mrefu na waombudsmani wa hiari katika vituo vilivyoteuliwa.
- **Advocacy for resident:** Ulinzi wa haki za wakazi

**ELIGIBILITY:** USTAHILI

- **Residents of nursing facilities, basic care facilities, hospital swing beds, sub-acute and transitional settings, and assisted living facilities:** Wakazi wa vituo vya uuguzi, vituo vya huduma za msingi, vitanda vya hospitali vya mpito, mazingira ya sub-acute na ya mpito, na vituo vya kuishi kwa msaada.

- **Volunteers under age 60 providing meal services during meal hours:** Wajitolea chini ya umri wa miaka 60 kutoa huduma za chakula wakati wa masaa ya chakula.
- **Individuals with a disability under age 60 in a housing facility primarily occupied by older individuals may receive nutrition services if the facility has an OAA congregate meal site:** Watu wenye ulemavu chini ya miaka 60 wanaoishi katika kituo cha makazi kinachotumiwa hasa na watu wazee wanaweza kupokea huduma za lishe ikiwa kituo hicho kina tovuti ya milo ya pamoja ya OAA.
- **Individuals with a disability under age 60 who reside with an individual age 60 and older:** Watu wenye ulemavu chini ya miaka 60 wanaoishi na mtu mwenye umri wa miaka 60 na zaidi.
