AN ORDINANCE TO ANNEX ALL THAT PART OF LOT G, BLOCK 1, JOHNSON'S FOURTH, NOT PREVIOUSLY ANNEXED TO THE CITY OF GRAND FORKS, NORTH DAKOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:

Section 1.

The following territory is hereby annexed to the City of Grand Forks, North Dakota, together with the full width of all platted streets and public rights-of-way contiguous thereto:

ANNEX ALL THAT PART OF LOT G, BLOCK 1, JOHNSON'S FOURTH ADDITION, NOT PREVIOUSLY ANNEXED TO THE CITY OF GRAND FORKS, NORTH DAKOTA.



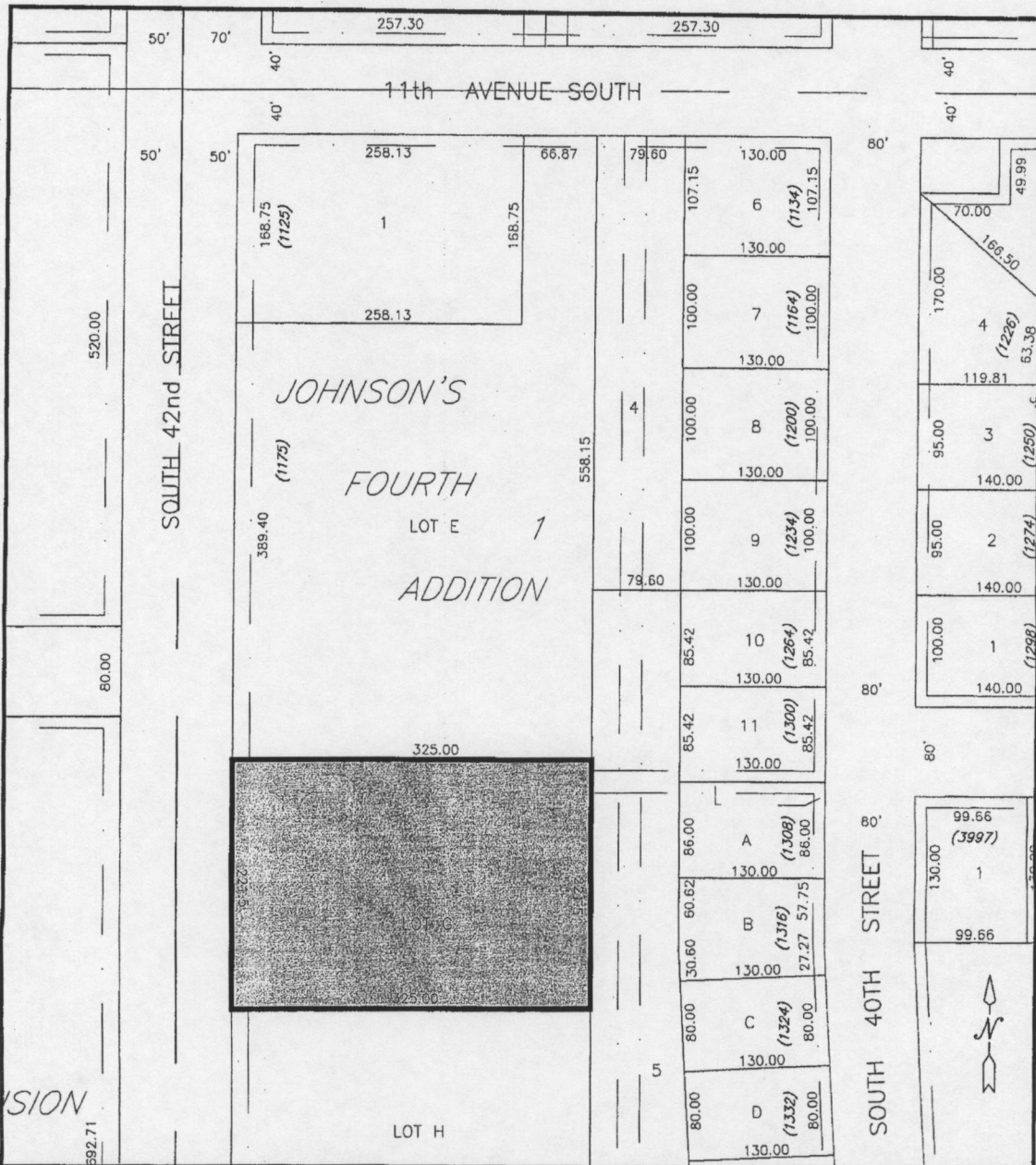
