

Purpose

If you are applying for an extension of time to file your 2014 North Dakota individual income tax return, you may make an extension payment to prepay the tax that you expect to owe to avoid paying extension interest.

If you make an extension payment, you must file Form ND-1 and claim the payment on page 2, line 27; you may not file Form ND-EZ.

The payment must be made no later than April 15, 2015, to avoid extension interest.

Important. Do not use the voucher below if you:

- Choose to make the payment electronically—see “How to make payment” for your payment options.
- File your return on or before April 15, 2015.
- Pay your balance due after April 15, 2015.

Any tax paid with your return is subject to extension interest.

How to make payment

If paying by check or money order, make the check or money order payable to “ND State Tax Commissioner,” and write last four digits of social security number(s) and “2014 ND-1EXT” on check or money order. Complete the payment voucher below, detach it from this page, and mail it with the check or money order to:

Electronic payment option. Instead of paying by check or money order, the payment may be made electronically online through Fidelity National Information Services (FIS), a national electronic payment service. The payment may be made by credit or debit card, or by electronic check. To pay electronically, go to www.nd.gov/tax/make-payment.html.

Fidelity National Information Services charges a fee for this service, which varies depending on the payment method used. North Dakota does not receive any part of this fee. The amount of the fee will be provided during the transaction with an option to continue or cancel the transaction.

If paying electronically, do not use this payment voucher.

Privacy Act Notification. In compliance with the Privacy Act of 1974, disclosure of a social security number or Federal Employer Identification Number (FEIN) on this form is required under N.D.C.C. §§ 57-01-15 and 57-38-31, and will be used for tax reporting, identification, and administration of North Dakota tax laws. Disclosure is mandatory. Failure to provide the social security number or FEIN may delay or prevent the processing of this form.
